

#### City of Redfield: Zoning Administrator Position

The City of Redfield is in need of a Zoning Administrator. The Zoning Administrator is responsible for assisting citizens in determining what zoning forms apply to their requested action and answering questions on how to complete the forms, reviewing building applications and supporting documentation to determine compliance with the City of Redfield Zoning Ordinances, which establishes the procedures that citizens must follow any time they wish to build or alter any structure in the community.

Duties of the administrator include: issuing permits and certificates of occupancy, advising citizens on alternatives if a proposal is not in compliance, suggesting alternative procedures (such as a variance or special exception) or advising on the appeal process should the applicant disagree with the administrator's decision. Investigating alleged violations of the ordinance and initiating enforcement proceedings when necessary to correct a violation.

To qualify for this job, you need a valid driver's license, high school diploma or GED and skills to read and follow the City of Redfield Zoning Ordinances. This is a paid position, \$130 monthly. The City of Redfield is an Equal Opportunity Employer.

#### Gardening Tips for May in Zone 5 (Redfield)

What a rollercoaster of spring weather we are having this year. As I write this, my flowers needed to be covered (to make sure all the plants are not damaged and blooms do not fall off due to the cold temperatures), I have needed to postpone some of my early planting, and I have watched my apple trees drop blossoms (due to the cold temperatures and strong winds). Even with these extremes, I have spinach and onions out of the ground. I also have seven buckets of potatoes planted and waiting for warmer temperatures. Last month I started 20 different vegetables from seed and I am waiting for them to emerge from the soil.

Even with these weather setbacks there are plenty of things to think about prior to planting the bulk of the garden. Here are some things to do this month.

#### Gardening "To Do" Tips by Month for Redfield, IA

- Have a rain gauge measure rainfall so you know when to water your plants. If your garden has clay in the soil, water has difficulty moving out of the root zone. Too much water can cause root rots.
- Sow seeds outdoors: beets, carrots, chard, kohlrabi, cabbage, spinach, turnips, onion sets, and peas.
- Keep hilling potatoes. If you do not hill the potatoes, the sun will turn the skins green.
- Plant new shrubs and trees.
- Begin hardening off the plants you started inside from seeds in April (set them outside during the day and bring them inside at night).
- Fertilize perennials at this time of the year (do not fertilize in season or fall)
- Protect transplants from insects (especially cutworms). Support tomato plants with a four inch stick directly next to the stem. When inserted
  into the ground the stick should be two inches below and two inches above the ground. If you see cutworms, do not be afraid to pick these
  insects off of the plants and squish them.
- •In April it should be safe to plant most vegetables outside.... Cucumbers do not do well unless the soil is warm.
- Have your trellis in place for tomatoes, peas, pole beans, and gourds.

#### Clinic News

**Environmental Allergies:** (adopted from the Cleveland Clinic allergy website) So far 2024 has been a banner year for environmental allergies. The warm winter and early spring have caused plants to bloom earlier than usual extending the allergy season.

Medically known as allergic rhinitis (Hav Fever), it is caused by an over-reaction of a person's immune system to substances such as pollen, mold, pet dander and insects. This allergic reaction is characterized by itchy, watery eyes, itchy nose, sneezing and head congestion. These symptoms can be controlled reducing exposure to allergens, life style changes, anti-allergy medications and immune therapy such as allergy shots.

The small particles in the air called allergens cause release of histamines that trigger allergy symptoms. These can include stuffy runny nose, sinus pressure, headaches, post nasal drip and dark under eye circles. Although being called Hay Fever, these symptoms are usually not caused by hav and usually are not associated with fevers. Unlike similar symptoms caused by common cold viruses allergies are not contagious.

Seasonal allergies occur in spring, summer and fall; but perennial allergies can occur year round and can be caused by dust mites, pet dander and cockroaches.

About 1 of 5 people in the US suffers from allergies (allergic rhinitis). The common cold usually does not cause watery, itch eves. A cold can cause muscle aches and pain that usually don't occur with allergies. And a cold usually lasts about one week, whereas allergic rhinitis symptoms last longer – as long as the allergens are in the air.

Allergic rhinitis can be diagnosed through skin testing or by detecting allergy antibodies in the blood. Allergy treatments are many and include medicines, nasal sprays, drops by mouth and injections. It is best to talk with your medical care provider before starting medicines for allergies especially if you have medical conditions or are pregnant.

**Prevention:** Allergy symptoms can be reduced by:

- 1: Closing windows when pollen count is high and using the air conditioner:
- 2: Keeping pets out of the bedroom;
- 3. Putting filters on the vacuum cleaner:
- 4. Avoid rubbing your itchy eyes or nose:
- 5. Washing hands after playing with pets;
- 6. Putting covers on pillows and mattresses:
- 7. Changing clothes and showering as soon as you come indoors. Consider seeing a medical care professional if allergy **symptoms are:** 1) getting in the way of your life 2) interfering with sleep 3) not controlled by medication

**Sun Protection**: Avoiding sunburn and decreasing the chance of developing skin cancer by applying sun screen with a sun protection factor (SPF) of at least 30, or covering up your skin with clothing. Remember the only safe tan comes in a can.

#### **Council Minutes**

The Redfield City Council met on Tuesday, April 2, 2024. Mayor Reed called the meeting to order at 7 P.M. Present were council members Gish, Stonehocker, Cave, Meyers and Danielson, P.W. Director Danielson, W.W. Supt. Clausen, Fire Chief Short and Librarian Stonehocker. Visitors were Steven & Kristy Roberts. Gary Keeton. Bruce Stanley. Doug Jones. Obje Meyers. Deputy Myers and Clerk Light. Attorney Doll was absent.

Meyers moved and Danielson seconded to approve the agenda with three additions under Old Business. A job summary for the City Clerk position, Building Inspector position and employee Health Insurance. Roll call vote-all ayes. Motion carried.

After discussion on the bills, a motion was made by Meyers and seconded by Gish to approve the consent agenda which included the minutes of the previous meeting and claims paid. Roll call vote - all ayes. Motion carried.

Librarian Stonehocker reported 290 patrons for the month with 669 in circulation. Book club will be on Wednesday, April 10th at 7 P.M., Chair Yoga every Wednesday at 2:30 P.M., and Cathy (Weesner) Van Hove will be at the library on Wednesday, May 1st at 7 P.M. to discuss her book, which is about living fearlessly with Type 1 Diabetes.

Zoning Administrator Reed reported two building permits were issued, one at 1511 Grant Street for an addition and one for solar panels at 1410 Taylor Street.

Fire Chief Short reported 21 calls for the month, nine were fire calls and 12 were EMS calls with one billable to the City of Linden.

Council member Danielson spoke about the terrible smelling smoke coming from the Stine property. Danielson said there are two daycares in her area as well as the WCV Middle School and the air quality is horrible. She will speak with Ted Trewin at D.C. Environmental Health and will also contact the Department of Natural Resources, air quality division if needed.

A police report was not received but Deputy Myers was on hand to answer any questions.

Doug Jones visited with the council about the importance of trees and why they should be allowed on the parking area in town. Jones does not agree that Gary Keeton must get his trees moved from the city parking as the City Ordinance in place at the time they were planted allowed for them. A new Ordinance was put in place in June of 2023, after the fact. Keeton also added that yes, he signed the agreement to have them moved but then added a verbal agreement that he would move his as soon as everyone else in town moves their trees on the parking. Meyers made a motion and Gish seconded to allow a 90-day extension per Attorney Doll's review of the previous Ordinance. Roll call vote - all ayes. Motion carried.

Steven and Kristy Roberts thanked everyone for help on the day of the fire. They also spoke about an emergency Community Catalyst Grant, a building remediation program fund for the purpose of providing grants to cities for the redevelopment, rehabilitation or deconstruction of buildings to stimulate economic growth or reinvestment in the community. Roberts has been talking to Jim Thompson at Region XII, who will help with the grant.

P.W. Director Danielson said there is an issue with the storm sewer on Grant Street, he will look into it further. The water issue at Casey's was caused by a problem with their water softener, water was restored shortly after finding the problem. Danielson will put cones back out at the county shed to keep anyone from parking there.

Fireworks were discussed. Cave made a motion and Danielson seconded to only allow fireworks on July 4th from 9 A.M. to 10:30 P.M. and again on December 31st from 9 A.M. to 10:30 P.M. Roll call vote - Gish, Stonehocker, Cave and Danielson, all ayes. Meyers, nay. Motion carried. Clerk Light will have Attorney Doll prepare the ordinance change for the May meeting.

Danielson moved and Meyers seconded to approve Resolution 2024-04, a Resolution to Consider Granting Conditional Easements Over City Owned Real Estate, that would benefit the properties locally known as 903 and 913 Jefferson Street, Redfield, Iowa. Roll call vote - all ayes. Motion carried.

The Comp Plan Update, an Open House with Bolten & Menk will be held on April 8, 2024, from 4 P.M. to 5:30 PM. for the Comprehensive Plan with the Planning and Zoning members meeting at 6 P.M. for a Public Hearing to review and consider adopting the Comprehensive Plan by resolution.

Nuisance notices were discussed. Letters were sent to appx. 10 homeowners to clean up their properties. The council would like to see the pictures that go with each letter.

A job summary from the Redfield City Code was handed out for the City Clerk position. Danielson and Gish will look **it** over and make any necessary changes. This will be reviewed again at the May meeting.

Gish made a motion and Stonehocker seconded to keep the

#### GENERAL INFORMATION

#### SOURCE WATER ASSESSMENT INFORMATION

This water supply obtains its water from the sand and gravel of the Alluvial aquifer. The Alluvial aquifer was determined to be highly susceptible to contamination because the characteristics of the aquifer and overlying materials provide little protection from contamination at the land surface. The Alluvial wells will be highly susceptible to surface contaminants such as leaking underground storage tanks, contaminant spills, and excess fertilizer application. The IDNR will inform you if you must deliver a copy of your report to any other agency (e.g., County Board of Health).

3. Complete and return the enclosed CCR Certification Form to the IDNR Water Supply Operations Section at 502 E. 9th Street, Wallace State Office Building, Des Moines, IA, 50319-0034, no later than October 1, 2024.



#### **Rex J. Harvey Foundation**

A fund has been set up to raise money for a statue of Rex J. Harvey of Redfield.

Rex attended Dexfield High School, where he helped his track and field team win two state championships under the legendary coach Dean Roe. He then earned a Bachelor of Science in Mechanical Engineering at Iowa State University, where he attended on an athletic track and field scholarship. During which he participated in four U.S. NCAA Division I Championships.

Rex was a Vietnam War Veteran, who served as a Captain in the United States Airforce. As a member of the US Military track and field team he represented the United States at many international competitions, as well as the 1972 and 1976, US Olympic Trials in the Decathlon.

Rex went on to earn a Master of Science Degree in Systems Management at the University of Southern California. During his many years as an engineer, he designed and holds several patents for nozzles. He ended his career as a Research Development Engineer at Parker Corporation in Cleveland, Ohio.

Rex continued his track career as a master's competitor, during which he won 13 straight national decathlon championships, as well as several world championships in the decathlon, pole vault, and as a member of several relay teams.

Rex was inducted into the USATF Masters Hall of Fame in 2000. He was an integral part of developing age-graded tables for scoring masters track and field athletic performances. He was elected to two terms as Vice President Stadia of World Masters Athletics (WMA). At the time of his death, he was serving as the President of USATF Masters Track & Field. Rex had accumulated one million total decathlon points, making him a World Record holder.
